Dear Parent or Guardian,

Thank you for your interest in having your child participate in the Gilroy Youth Center: Fall Afterschool Program. Given the unique circumstances due to the current COVID-19 pandemic and Santa Clara County Public Health Mandatory Directives for Programs Serving Children or Youth, the Gilroy Youth Center has implemented several changes to our Afterschool program to prioritize the health and safety of your child, family, and staff. In accordance with Santa Clara County Public Health's Directives, these changes include:

- Modified program activities to comply with 6 feet social distancing requirements
- Reduced program group size, program times, and session days.
- Regular sanitizing and hand washing procedures during program
- Periodic staff testing for COVID-19
- COVID-19 Site-Specific Protection Plan – SCC Public Health (*Available upon request*)
- COVID-19 positive case reporting protocols (*Available upon request*)
