Request for inspection shall be made forty-eight (48) hours (2 working days) prior to work. Inspector will be Urban Forester or designated agent (408) 846-0444. (Inspection not required for standing permits.)

**Agreement:** Applicant agrees to only perform scope of work requested. Applicant further agrees to observe all conditions specified under the Street Tree Ordinance, City Tree Planting Specifications, attachments or any special conditions. Failure to comply will constitute violation of Street Tree Ordinance #75-13.

**Liability:** It is understood and agreed that the applicant assumes all risks for loss, damage, liability, injury, cost or expense that may arise during or be caused in any way by such work performed under the Street Tree Permit in the city right-of-way. The applicant further agrees that in consideration of being permitted to perform said work, he, it or she will save and hold the said City of Gilroy and said Community Services Department and/or their employees free and harmless from any loss, claims and disability or damages, and/or injuries to persons and property that in any way may be caused by applicants' performance.

I, the undersigned, hereby certify that I will be personally responsible on behalf of the applicant for any damage sustained by the grounds, building, or vehicles occurring during the performance of said work by the applicant.
