<b>E-113-88</b>	<b>July 18, 2022 - August 12, 2022</b>	<b>FILING PERIOD – CANDIDATE NOMINATION PAPERS EC 10220 et seq.</b>
E-88-83	August 12, 2022 – August 17, 2022	Extended candidate filing period. Candidate filing is extended if an incumbent eligible for re-election <b>does not</b> file nomination papers prior to 5:00 p.m. on August 12, 2022. Incumbents are not eligible to file during the extended period. EC § 10225(a)
E-88	August 12, 2022 at 5:00 PM (No exceptions)	Last day candidates may circulate nomination papers and submit to the City Clerk; last day to file Candidate’s Statement and Candidate Form 700 (unless filing period extended)
E-88-78	August 12, 2022 - August 22, 2022	Review period for candidate statements (begins after 5:00 p.m.)
E-83 to Election Day	August 17, 2022 – November 8, 2022	Nomination petitions may be viewed only, <b>not copied</b> , as of the 83rd day prior to the election.
E-85	August 15, 2022	Last day to withdraw (but not change) candidate statement for offices whose filing closed on E-88. EC § 13307
E-82	August 18, 2022	Randomized Alphabet drawing, conducted by Sec. of State, determines order candidates appear on the ballot.
E-82	August 18, 2022	Last day to withdraw (but not change) candidate statement if nomination period extended to E-83. EC § 13307
E-40	September 29, 2022	First Day to Mail Voter Information Pamphlets
E-40	September 29, 2022	First Pre-Election Campaign Statement due (period 7/1/2022 - 9/24/2022). GC § 84200.8
E-29	October 10, 2022	First Day of Mailing Vote by Mail Ballots & Early Voting Period Begins EC § 3001
E-28-1	October 11, 2022 – November 7, 2022	<b>Early Voting Period at the ROV Office</b>
<b>E-15</b>	<b>October 24, 2022</b>	<b>Last Day to Register to Vote. EC §§ 2102, 2107</b>
<b>E-14-0</b>	October 25, 2022 – November 8, 2022	<b>Conditional Voter Registration</b> Open for a full 14 days prior to the election and must be done in person at the ROV office or at any Vote Center. Vote centers are open 11 days prior to the election. Please check ROV’s website for latest information.
E-12	October 27, 2022	Second Pre-Election Campaign Statement due (period 9/25/2022 - 10/22/2022). GC § 84200.8
E-7	November 1, 2022	Last Day to apply for Vote by Mail Ballot (At ROV Office)
E-90 to Election Day	August 10, 2022 - November 8, 2022	Late Contributions/Independent Expenditure Filing - \$1,000 or more reported within 24 hours of receipt by fax, telegram, overnight or personal delivery via Form 460.
E-2	November 6, 2022	Third Pre-Election Campaign Statement due (period 10/23/2022 – 11/1/2022). <b>Gilroy Filing Requirement</b>

E+22	November 30, 2022	Elections Official to Notify Voter of Verification of Signature
E+28	December 6, 2022	Last Day to turn in unsigned ballots or signature verification statements.
E+30	December 8, 2022	Last day for County to certify election results to City. EC § 15372
	January 31, 2022	Semi-Annual Campaign Statement due. (period 10/23/2022 - 12/31/2022) GC § 84200
