- 7b. Briefly describe the present *physical appearance* of the site or structure and describe any major alterations from its original condition:

This classic, two-story crossgable structure is rectangular in form with much of its original material intact. The six-over-six windows in double hung wood sash appear to have much of the early glass.

The boxed eaves and plain frieze are the only decorative elements. The door and windows are framed in simple flat board. The sheathing is wide, horizontal board. A concrete foundation has been put under the house. Additions to the rear appear to the 1880s with shed roofs. The original form and architecture are intact.
