NOTICE IS HEREBY GIVEN that the Gilroy City Council, on Monday, April 6, 2026, will hold a public meeting in the City Council Chambers at City Hall, 7351 Rosanna Street, Gilroy, CA, at 6:00 PM, or as soon thereafter as possible, to provide direction on the funding allocations for the proposed PY 2026-2027 CDBG program and receive public comments.

NOTICE IS HEREBY GIVEN that the City Council of the City of Gilroy, on Monday, May 4, 2026, will hold a public hearing commencing in the Gilroy City Council Chambers at City Hall, at 6:00 PM, or as soon thereafter as possible, to consider the following item:

Adoption of the CDBG PY 2026-2027 Funding Allocations, PY 2026-2027 Draft Annual Action Plan, and Draft Citizen Participation Plan.

NOTICE IS FURTHER GIVEN that the City Council will receive public comments at the public hearing on the draft Plans and grant funding allocations for the CDBG program. The City anticipates receiving an estimated annual allocation of \$400,000 in CDBG funds and an additional \$906.74 in prior years' resources to be allocated to eligible PY 2026-2027 activities.

Interested parties are encouraged to attend the public meeting and public hearing as this is the time and place when comments on the funding allocations and draft Plans shall be heard and given due consideration. Persons who are unable to attend the public meeting and/or public hearing may submit written comments by email to Housing@cityofgilroy.org or by delivering them to the Housing and Community Services Division, 7351 Rosanna Street, Gilroy, CA 95020, prior to, or at the public meeting and/or public hearing to be incorporated into the record.

PUBLIC COMMENT PERIOD: In accordance with the City of Gilroy's Citizen Participation Plan and the requirements of the U.S. Department of Housing and Urban Development (HUD), regulation 24 CFR 91.105, a **30-day public comment period**, beginning March 13, 2026, and ending April 13, 2026, is being circulated to solicit public comments and questions regarding the grant allocations and draft Plans. Comments can be emailed to Housing@cityofgilroy.org and will be addressed in the final version of the Plans to be submitted to HUD for approval. The draft Plans are available on the City's website at www.cityofgilroy.org/cdbg and are on file with the Community Development Department at City Hall, 7351 Rosanna Street, and the Gilroy Library, 350 W. 6th Street.

The staff report for either the April 6 public meeting on the CDBG grant allocation recommendations or May 4 public hearing, where the City Council will consider adoption of the funding allocations and the

draft Plans, may be viewed on the City website (www.cityofgilroy.org) by 5:00 PM the Friday before each City Council meeting.
